To the best of my knowledge, my dog is in good health, free of communicable diseases and parasites, has been inoculated against distemper & respiratory viruses within one year of this date. (It is the responsibility of YOU and your veterinarian to provide that your dog is protected from viruses and disease), has not been exposed to distemper or rabies within the last 30 days, and has not bitten anyone within the last 14 days. If dog(s) requires medical attention & owner cannot be reached, the Kennel owner or manager may call veterinarian as named above or one of own choice or give medical attention, which seems advisable to him. The owner of dog shall bear all expenses. All dogs are boarded without liability on kennels part for loss or damage from disease, death, running away, fire, theft, and injury to persons, other dogs or property, by said dog or other unavoidable causes. Kennel shall exercise reasonable care for the dog delivered to the kennel for boarding by owner or his assignee. Owner expressly agrees the kennel's liability shall not exceed the lesser of the current value of a dog of the same species or the sum of \$400 per dog boarded. Owner further agrees to be solely responsible for any acts or behavior of said dog. Owner agrees to pay the rate of boarding above and all costs and charges for special services requested. Owner further agrees the dog shall not leave the kennel until all charges are paid. Owner of dog verifies that he/she is the sole and legal owner of the dog.
